Arraignment set on sex charge

LIVERMORE FALLS — A former bank executive who police say is a suspect in more than one sex crime is scheduled to be arraigned in 11th District Court on May 23.

Livermore Falls Police Chief Ernest N. Steward Jr. told District Court Judge John C. Sheidon that investigators had contacted "several victims, all pre-teen juveniles," in building their case against William H. Nickerson, 57, of Livermore Falls.

Despite the number of victims that Steward maintains exist, only one charge of gross sexual assault was levied against Nickerson by local police. Further charges may be filed by the District Attorney's Office, Stew-

ard said, though prosecutors had been given no information on the case by early Thursday afternoon.
