William Henry Hall, who on November 6, 1987, was found guilty in the above cases of a felony, but against whom the fixing and imposition of sentences was delayed pending a pre-sentence report and psychiatric examination, this day was led to the bar in the custody of the Sheriff of the City of Richmond, and also appeared Bradley Davis, his Attorney at law, and John P. Driscoll, an Assistant Attorney for the Commonwealth, and came Ronnie L. Gilder, his Probation and Parole Officer.

Whereupon, the pre-sentence report having been filed according to law and the defendant advised as to the contents thereof, and given the privilege of cross-examining the reporting officer thereon, and the psychiatric report of Dr. James C. Dimitris, having been considered and the arguments of counsel having been heard, after allocution of the defendant, it is the judgment of this Court that the defendant be confined in the penitentiary as follows:

(Case No. 87-807-F) fifteen (15) years in the penitentiary on the conviction of sodomy/ ^{of a minor} the last five (5) years of said sentence to be suspended; and

(Case No. 87-808-F) fifteen (15) years in the penitentiary on the conviction of sodomy/ ^{of a minor} the last five (5) years of said sentence to be suspended;

a total of thirty (30) years in the penitentiary with ten (10) years suspended.

Man is added to list of those most-wanted

A man charged with forcibly sodomizing two boys in June has been added to the list of Richmond's most-wanted people.

William Henry "Billy" Hall, 28, whose last known address was 2916 Chatham Drive, was added to the list yesterday. Hall brings to eight the number of people on the most-wanted list.

Juvenile Division Sgt. Philip Mangano said Hall had been living in a tent in a wooded area in the 1800 block Southlawn Ave.

He allegedly lured two children, ages 7 and 3, to his tent between June 16 and June 24 by offering them candy. The boys said a man showed them his tent and a gun and then sodomized them.

The children told their parents, and the parents went looking for the man on June 30. They chased him through the woods in the Oak Grove area of South Richmond but did not catch him.

Sgt. Mangano said Hall has been sighted in the city since then.

Hall is described as 5 feet 4 inches tall, weighing 150 pounds with blue eyes, brown hair and a fair complexion. He has a tattoo of a snake on one shoulder.

Man on wanted list surrenders to police

A 28-year-old man who was charged with forcibly sodomizing two boys in June, and who was added to the list of Richmond's most-wanted people on Wednesday, turned himself in to police last night.

Police arrested William Henry Hall, whose last known address was in the 2900 block E. Chatham Drive, about 3:40. He was being held in the city lockup in lieu of \$10,000 bond pending an appearance today in Richmond Juvenile and Domestic Relations District Court.

Hall is accused of sodomizing the

children, 7 and 3 years old, during June. Police said at the time that a man had lured the children to a tent where he was living in a wooded area in the 1800 block Southlawn Ave. by offering them candy. He then allegedly showed them a gun and sodomized them.

Detective Sgt. O.T. Clark said, "The heat was on. What with his picture in the paper and everything, he turned himself in."

With Hall's arrest, the number of people on the city's Top 10 list is seven.

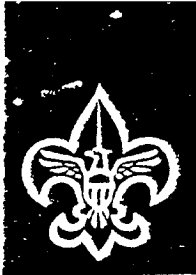
