Since we have received no reply to our letter of November 27, copy enclosed, from either you or Bill Raup, I regret that we must advise you that we have no choice but to again refuse Mr. Iannuzzi's application to register in both Pack 3040 and Troop 40.

John, the whole history of this situation has been one of long on promises and short on delivery. I have talked with Bill Raup at least three or more times on the phone. Each time he has pled other responsibilities which under the circumstances I know have existed in your council over the last year or more and which I have been thoroughly able to understand. However, I cannot overlook the fact that we still have not had the information which Bill has promised and until we get this we cannot take any action other than to continue to refuse Iannuzzi's registration.

You recently sent us a Scouter application for William Iannuzzi, 1209 Leaford Avenue, Cherry Hill, New Jersey. He serves as Assistant Scoutmaster of Troop 40 in District 12. As you know there has been considerable follow-up on our part with the county about additional information on Iannuzzi. Until we obtain this, we cannot accept Mr. Iannuzzi's application. I am sure you will recall that we had refused his application when he tried to register with us last February.

We will hold his application pending for one month. If we do not hear from either you or him by then, we will have to refuse his application.

Incidentally, we note his application says he is a "T" from Troop 40 to Troop 40. This is not possible when he is not currently registered in Troop 40. Therefore, he should be classified as "N" or "OR" and we need a fee for his registration if we will ultimately accept it.

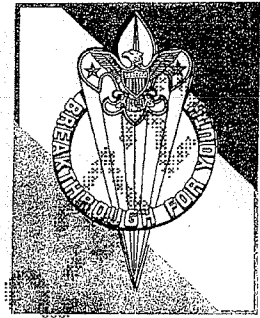
