Dear Paul:

In July, near the end of our 1986 summer camp season, Ron Patterson admitted to officer Gary Armstrong of the Medford Police Department that he had on several occasions entered the tents of sleeping Scouts and fondled their private areas.

The enclosed Medford Police Department Case report, which is highly confidential, provides all the investigation background.

Ron Pattersons' trial in the Klamath County Court system has been delayed time and again with continuances and motions to suppress the evidence. However in the fall 1987 Patterson pled guilty to sexual abuse II and was sentenced on December 29, 1987. A copy of the sentence order is enclosed.

Mr. Patterson is not currently registered, and I suggest that the Boy Scouts of America take the proper steps to make sure he does not register at the end of his probation period three years from now.

Writer on 7-21-86 at approximately 1205 hours was contacted by Officer Gary Armstrong of this department indicating that he was in contact with subject [REDACTED] and [REDACTED] mother being [REDACTED] with reference to sexual abuse having occurred to [REDACTED] while he was at camp McLoughlin at Lake of the Woods, Klamath County, Oregon. [REDACTED] was at that location with the Boy Scouts of America, Troop 112 for a week long camp out from 7-13-86 to 7-19-86. This sexual abuse had occurred during the late evening hours of 7-17-86 and early morning hours of 7-18-86.

The sexual abuse being that a subject had entered the tent of [REDACTED] at the above time and date while [REDACTED] was in the tent alone and sleeping in his sleeping bag and that this subject had placed his hand on the penis of [REDACTED] on two occasions at that time and that the subject had attempted to again touch the penis of [REDACTED] after [REDACTED] had turned over on his stomach.

Writer obtained a taped statement from [REDACTED] with regards to the occurrences on that evening/morning.

Officer Armstrong had been advised previously of this occurrence and had already talked with Steve Kious of the Jackson County Childrens Services Division to apprise as to findings. Apparently Kious had been previously contacted by personnel of the Boy Scouts of America who had determined that the suspect in this case was a William Ronald Daniel Patterson, DOB 6-10-68 of [REDACTED] Eagle Point, Oregon, phone [REDACTED] who is further described as being WMA, 5-9, 155, with

Apparently Patterson known by [redacted] as Ron Patterson is the subject who admitted to fondling not only [redacted] but a number of the other juveniles at the camp out. The Childrens Services Division of Jackson County and/or the persons in authority at the Boy Scouts of America have or will be forwarding this information to the Klamath County Sheriff's Department as Lake of the Woods falls in their jurisdiction.

Writer in talking with [redacted] was advised by him that he had told the Senior Patrol Leader, a Lee Willis, and the Health Leader being a Jerry Frost of the occurrence.

Writer requests a copy of this case be forwarded to the Klamath County Sheriff's Office as well as to the Jackson County Children Services Division, Attention: Steve Kious.

I then stood up and cussed him out until he got out of the tent, then I found my flashlight which he had moved and stood at the entrance of my tent waiting to hear somebody move and I heard some movement up on the road approximately 20 feet away from my tent, I flashed the flashlight on him and he ran away.

This Continuation Report is in reference to a reported child abuse which occurred at Camp McLoughlin, Lake of the Woods, Klamath County, Oregon between the time of 7-15 and 7-18, 1986.

On July 18, 1986 writing officer went to the Boy Scout Camp located at Camp McLoughlin, Lake of the Woods, Klamath County, Oregon to put on a seminar on locating and identifying children who are sexually and physically abused to scout masters at the camp. Writing officer while at that location was advised that the problem had occurred and that a suspect had been located.

Writing officer after putting on the program contacted the Camp Director, Ferris Simpson, whose residence is [redacted], Grants Pass, Oregon, home phone [redacted], business phone number [redacted] and Camp McLoughlin phone number [redacted]. Writing officer also contacted Dennis Helland who is the program director for Camp McLoughlin, home address [redacted], phone number [redacted]. Writer also contacted the Camp Ranger, Philip M. Nydyck, address of [redacted] Shady Cove, Oregon.

Writing officer was advised by the three gentlemen that rumors started surfacing on Tuesday of a child having been sexually fondled by someone between the hours of 2:00 AM and 3:30 AM. They stated that since I was coming up on Wednesday tentatively, they decided to contact me and advise me of the situation. I was unavoidably detained, however, on Wednesday so it was Friday before I arrived at the camp and was advised at that time that rumor had it that two more boys had been sexually abused on Thursday night / Friday morning.

Writing Officer was advised by Mr. Simpson that they had been advised that the troops involved on Thursday night/Friday morning were Troop 40 and 112, however, were unable to identify who the boys were.

Armed with that information Mr. Helland and Mr. Dodyck stated that they did do some checking around the camp and found footprints around the tents and followed those in broken succession to the staff cabins and armed with the very sketchy description they were able to identify the person that they felt was responsible for the sexual assaults. The sexual assaults were described as someone sneaking into the tent, reaching into a sleeping bag and fondling the genital area of the boys.

Writing officer at that time contacted the father of the suspect, [REDACTED] of [REDACTED], Eagle Point, Oregon, phone [REDACTED]. Mr. [REDACTED] was advised that a situation had occurred in camp on 3 occasions and that his son was believed responsible. His son is 18 years of age, however, we felt that it was important that his father be aware of the situation before contact was made.

At approximately 1150 hours on the 18th of July, writing officer contacted the suspect and identified him as Patterson, William Ronald Daniel, [REDACTED], Eagle Point, Oregon, phone [REDACTED], DOB of 061068, described as having brown hair, 5-9, 155, OOL [REDACTED].

Writing officer advised the suspect of the reason that he had been called into the office and I advised him that if we were able to locate victims, criminal charges would probably be pressed against him. I asked him if he wished to discuss the situation with me at that time and at that point he stated that yes he had in fact fondled the genital areas of 3 boys during the week.

Writing officer asked him if he could expound on that and he stated on Tuesday night he had snuck into a camping area reserved for special camping personnel who were working on merit badges and had reached inside of a sleeping bag and fondled the genital area of the boy there. He did not seem to know who the boy was only that he had fondled the genital area.

William Patterson then stated on Thursday night he again went to the area of Troop 40 and 112 and fondled one boy in each by first sneaking into their tent area, reaching into their sleeping bag and fondling their genital area. He stated each time he left before the person was awake so they would not see who he was.

After discussing the problem with William for a short time, writing officer asked Mr. Patterson and Ferris Simpson, the camp director to come into the room. William admitted to both his father and to Ferris Simpson that he had been the one responsible for the activities in camp and apologized. He also advised Mr. Simpson that he would be leaving the camp so no further problems would occur while he was there. Writing officer again advised William Patterson that if a victim was identified that criminal charges would be filed against him in a court and that he would have to answer to those charges at that time. William Patterson stated that he understood that what he had done was wrong and was very apologetic.

At approximately 1600 hours on the 18th, writing officer contacted Steve Klous of Children Services Division and advised him of the situation at Camp McLoughlin. Writing officer advised him that we were in the process of attempting to

locate a victim so we would be able to file criminal charges or at least advise Klamath County of the incident so they could take appropriate steps there.

On July 21, 1986, writing officer was contacted by [REDACTED] and a [REDACTED] and advised that he had been a victim of one of the assaults. Writing officer asked them if they would mind coming to the Medford Police Department and contacting Investigator Lloyd where a report could be taken and processed through the system. At approximately 1215 hours, on the 21st both [REDACTED] and her son did arrive and a report was filed by investigator Lloyd.

As of the time of this report we have not been able to identify the other victims at camp, however, an attempt is still being made by the Camp Director Ferris Simpson and other staff at camp. It should be noted that the boys involved have now left the camp.

Writing officer advised all of the scout masters that should they determine if one of their children is abused that they should contact the parent of the child immediately and make sure they are aware of it and also take appropriate steps in seeing that is reported.

This continuation report is in reference to a sexual abuse case which occurred at Lake of the Woods, Oregon in Klamath County Oregon. The suspect in this case is a WILLIAM RONALD PATTERSON, DOB/06-10-68.

On 07/24/86, Writing officer was at Camp McLoughlin located at Lake of the Woods, Klamath County, Oregon.

While at that location writing officer contacted a victim of a sexual abuse which had occurred in the early morning hours of 07/21/86 or 07/22/86, the victim in this report is [REDACTED] address of [REDACTED], McKinleyville, CA, phone number [REDACTED].

Writing officer contacted [REDACTED] and advised him that I was doing a follow up investigation on the sexual abuse that had occurred at Camp McLoughlin during the week of July 21st. Writing officer advised [REDACTED] that I was made aware that he was one of the reported victim and requested that he speak to writer about the occurrences.

[REDACTED] advised writing officer that either on Monday morning or Tuesday morning he was not sure, during the early morning hours an unknown male subject had entered his tent in the demonstration camp area at the camp and had attempted to touch him. He stated the subject had put his hand on his left hip and at that point the suspect fled from the tent. [REDACTED] stated he did not get a good look and also again stated he had not been touched in the genital areas by the suspect, only on the left hip. Writer advised [REDACTED] that he

should advise his parents of what had occurred when he arrived home and also gave him my business my card and had them contact me. Writer also contacted [REDACTED] scout master, Norman Arrowsmith of [REDACTED] [REDACTED], Arcatia, California 95521. Mr. Arrowsmith had not been in camp training the week of the incident but again he assured writer that he would contact the parents to make sure they were aware of what had happened while at camp.

On 07/25/86 at approximately 11:00 A.M., writing officer contacted the third and final reported victim of sexual abuse at the camp. This subject is [REDACTED] of [REDACTED], Central Point, OR. Writing officer also contacted the subject's parents, [REDACTED] and his mother [REDACTED] [REDACTED], all of [REDACTED], Central Point, OR, phone number [REDACTED].
