On June 27, 1958, Wylie J. Taylor was charged in the City Court of Phoenix Arizona, of Child Molesting and found guilty. Judge on the bench was the Honorable Pensinger, and the defense attorney was D. Shortridge, of Phoenix Arizona. Wylie Taylor was given a 90 day sentence and after psychiatric examination and councilation his sentence was suspended.

I have consulted with Rev. T.C.Smallsreed, pastor of the church that sponsors the Cub Pack and he is in harmony with the removal
